Filing a tax return means checking your salary and other income over the course of a year and calculating your taxes. You can file a tax return at the locations listed below.

Please Bring: (For more information, please contact the tax office.)

- Documents showing your salary/earnings for 2025 (Tax withholding slip, etc.)
- Bank Account Book
- Zairyu Card and My Number Card (or document displaying your My Number)
- If you have life insurance, etc., please provide proof of the amount paid (receipts, certificates, and so on).
- If you sent money overseas to support your family, please bring documents showing how much and that prove your relationship.

City and Prefectural Resident Tax Declaration / 市・県民税の申告

If you are a resident and fit one of the following cases, you may need to file a city or prefectural resident tax return at your city hall. Please inquire at the Resident Tax Division.

- A person who receives a salary from more than two companies.
- People who are unemployed and are dependents of people who live outside of Kakamigahara City.
- * Those who file a final tax return do not need to file a city or prefectural tax return.
