Extrordinary Special Benefit

Those experiencing increased hardship due to Covid-19 can recieve an additional benefit (100,000 yen per household)

Households Eligible for the Benefit ①

Any household that was declared exempt from paying Residence Taxes as of December 10, 2021.

You will be sent a confirmation letter on February 10.

- Please check your bank statement
- ➤ Please check the necessary boxes (☑)
- Please use the enclosed envelope to return your form.

Households Eligible for the Benefit ②

Households which experienced financial hardships similar to case $\, \mathbb{O} \,$ as of January 1, 2021.

Please bring your application form, *Zairyu* Card, Bank Record Book, and some Proof of Salary to the office in the City Hall 2F. Applications will be accepted from February 14.

Junior High School Entrance Letter

All children entering junior high school from April (those born between April 2, 2009~ April 1, 2010) will be recieiving a letter.

If any of the following happens, please contact the School Education Division.

- > You do not recieve a letter
- > If your child will enter a national or private junior high or special junior high.
- An error in name or address.
- ➤ If you change address or other things before starting school.
- ➤ If you receive a letter from other cities.
- > If your child is unable to enter school due to illness or other situation.

You can report your Income taxes at the following places and dates:

Sangyo Bunka Center 2F Conference Room Kakamigahara City, Nakasakura Machi 2-186	February $16 \sim 28$ $9:00 \sim 15:30$ Closed Saturdays, Sundays, and holidays.
MASA 21, 4F (Aeon) Gifu City, Masakinaka 1-2-1	February 16~ March 15 9:00 ~ 17:00 Closed Saturdays, Sundays *, and holidays. * Exception: Sunday February 20 and 27 is open

Please remember to get a service number for Income Tax services. These can be obtained on the morning of the day from 8:30 AM.

What to bring with you:

げんせんちょうしゅうひょう

- > Something showing your salary/earnings for 2021 (源泉 徵 収 票 gensenchoushuuhyou/salary slip, etc.
- Evidence of payments for insurance (if enrolled) such as receipts, etc.
- > If you sent money abroad to support family members, bring recepits as well as documents establishing a relationship.
- Bank Record Book.
- Zairyu card and something with your "My Number" printed on it.

確定申告 kakuteishinkoku (Income Tax Report)... Your taxes are calculated based on all income, salaries,

revenues, etc, you received over a one year period.
