# **Municipal Housing Applications**

Applications for subsidized Municipal Housing will begin July 1<sup>st</sup> and end on July 15<sup>th</sup> (Office is open from 8:30AM~5:15 PM Weekdays).

Successful applicants may move in October 1<sup>st</sup>.

This year the usual lottery system has been suspended due to the COVID-19 pandemic. To protect public safety, the city hall will eschew the gathering of hopefuls to draw lots and determine housing. Rather, the applications will be reviewed and assigned a housing space. Applicants will be notified by the city hall of the results of the selection.

Rent varies depending on the location and room size:

Location	Room Type	Rent/Month
Yuhigaoka Dai 1 Complex	2K	13,500
Yuhigaoka Dai 2 Complex	2DK	20,000
Yuhigaoka Dai 2 Complex	3DK	24,000

All rooms require an upfront deposit payment of three months' rent.

#### A Reminder About Plastic Shopping Bags

Please keep in mind that stricter policies regarding environmental protection go into effect from July 1, further restricting the use of plastic shopping bags. Consumers are encouraged to make more use of eco bags and packs. Be aware that this is in fact a national policy and not a local measure, so be prepared to either pay extra for bags everywhere, or have your own handy.

#### My Number Card Updates

Until now, upon arrival to Japan visitors received a paper My Number card for their use which could be used as an ID. The style and usage of the card will be changing. This also applies to new citizens (which would basically be babies, obviously).

For those who already possess the older version of the paper card, note that this card is still valid and you may continue to use as a form of ID as before (though some places will require a family registry or similar document with the number displayed for confirmation), and of course if you change your address, you need to immediately update your card; again, the new paper cards being issued from now on cannot be used as ID. For this, you will need to get the plastic card.

Please submit (or post marked if mailed) by June 30<sup>th</sup> to the Child Raising Division in the City Hall or the Citizen's Service Center.
